Updated Standards for Voting Systems at E-Meetings

E-meetings have gained popularity as a means for holding both board and shareholders' meetings during the Covid-19 pandemic. Board and shareholders' E-meetings are required to meet the security protocol standards set forth in the Notification of Ministry of Digital Economy and Society re: Standards for Electronic Conferencing Security, B.E. 2563 (the "DE Notification") as introduced by our previous newsletter (LINK).

On 7 September 2021, the Ministry of Digital Economy and Society issued the Notification re: Standards for Electronic Conferencing Security (No. 2), B.E. 2564 (the "DE Notification No. 2"), which became effective on 8 September 2021. The DE Notification No. 2 added additional definitions, measures and requirements on voting systems and has enabled the use of a separate voting system from the e-meeting control system.

Key Requirements of Voting Arrangements for E-Meetings

Voting arrangements under the DE Notification No. 2 are as follows:

- a voting system that allows attendees to vote electronically.
- a controller of the voting system who may be the same or a different person than the meeting control system controller.
- a meeting arranger who chooses its own voting system or that of a service provider.
- compliance with the measures for electronic voting. as follows:
 - universal and equal suffrage—allowing voting by all attendees eligible to vote and all votes will be counted towards a resolution;
 - free suffrage attendees receive sufficient information and time for voting;
 - privacy all votes are kept secret;
 - security (Information Technology Security) a system that includes basic confidentiality, integrity, and availability standards; and
 - prior notification all attendees are informed prior to the vote of the conditions for voting and counting procedures.

Process for Voting at E-Meetings

If the voting system is separate from the meeting control system, the following process must be included for voting through the voting system:

- identification of attendees before starting the voting process;
- communication with attendees during voting process;
- access to documents presented for e-Meetings by the attendees eligible to vote;
- storage of records or evidence of voting via the voting system;
- storage of computer traffic data of all voters as evidence; and
- a channel for attendees to notify meeting controllers of any disruptions during the vote.

Under DE Notification No. 2, a voting system can also be examined and certified for its conformity by the Electronic Transactions Development Agency (ETDA) or other agencies specified by ETDA in the same manner as a meeting control system. If the system is certified by the said agency, the system is considered to be compliant with the standards set forth in the DE Notification No. 2.
